The Republic of Serbia has received a financing in the amount of US\$ 30,000,000 equivalent from the World Bank toward the cost of the CMDP Project, and it intends to apply part of the proceeds to payments for consulting services to be procured under this project.

The scope of work of the Head of Legal Advisory shall include, but not be limited to the following:

- Organization, oversight, and support in the implementation of the Capital Market Development Strategy for the period 2021-2026 from the legal perspective,
- Leading and coordinating the legal team engaged in capital market development issues;
- Review, oversight and support of the drafting of relevant opinions, memorials, contracts and other acts and legal documents,
- Support the drafting and adoption of securities laws and bylaws;
- Cooperation, coordination and liaison with different national institutions in the Republic of Serbia;
- Other relevant activities as instructed by the Project Manager and/or Assistant minister in charge in the MoFFS

The Consultant assignment will be for a period ending with August 31, 2028 conclusively.

The Consultant shall provide full time service for the life of the Project. If contracted, the Consultant shall not have other full or part-time assignment during his/her engagement under this contract.

Required qualifications and skills:

- University degree in law; bar exam will be considered as a distinct advantage,
- Minimum 15 years of relevant work experience as a legal manager, legal counsel, head of legal department and/or consultant in financial institutions (public, or private),
- Minimum 10 years of experience in dealing with securities law in the Republic of Serbia,
- Minimum 5 years of experience in drafting of legislation. Drafting of securities laws and bylaws will be considered as a distinctive advantage,
- Advanced user of MS Office (especially Excel),
- Minimum knowledge of written and spoken English that equals B2 level,
- Experience in managing teams.

The Central Fiduciary Unit (CFU) of the MoF now invites eligible Consultants to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (scanned diplomas to be sent with CV).

The attention of interested Consultants is drawn to paragraph 3.16 and 3.17 of the *World Bank's Procurement Regulations for IPF Borrowers – Procurement in Investment Project Financing Goods, World, Non-Consulting and Consulting Services, July 2016, revised November 2017, August 2018 and November 2020* (“the Regulations”) setting forth the World Bank’s policy on conflict of interest.

A Consultant will be selected in accordance with the *Open Competitive Selection of Individual Consultants* as set out in the Regulations, article 7.36 and 7.37 "Open Competitive Selection of Individual Consultants”.

The candidates will be evaluated applying the following evaluation criteria:

- Qualifications and General experience (40 Points)
- Specific Experience relevant to the Assignment (60 Points)
